**Tender Notice**

The Consulate General of India, Ho Chi Minh City invites bids from reputed Companies in the field of construction to do a project for Government of India which includes installation of the bust of Mahatma Gandhi in Ho Chi Minh City. The details related to the work in this regard to be undertaken are given below:

- a) Construction of the foundation (approx. 28 sq.m.) and construction of pedestal (LxBxH:1.73x1.22x1.31 meter) for installation of the bust.
- b) The foundation and pedestal should be covered with granite stone.
- c) The bust (dimension: HxLxB : 107x126x72 c.m.) needs to be installed at the site: Tao Dan Park, Ben Nghe Ward, District -1, Ho Chi Minh City.
- d) An existing stone sculpture in the park needs to be relocated to another location of the park. (The sculpture is near to the proposed site of installation of the bust of Mahatma Ganhdi.)
- e) Prepare a beautiful landscape around the bust.
- f) Installation of light to increase aesthetic appreciation of the landscape and water system (2-3 water lines) for regular cleaning of the pedestal, bust and the surroundings.
- h) A plaque with a remark to be installed. (It will be provided separately.)

**General Information and Instructions for Bidders:**

2. The company should meet the following criteria in terms of experience:
  - i) It should have at least two years of experience in the field of construction and beautification of landscape – established prior to 31 December 2019.
  - ii) It should have executed at least four similar kind of activities in the past two years.
  - iii) It should not have been barred by any legal authority in Vietnam or in India to develop the construction site.



3. A single bid on the cost of the project may be submitted by post on the letter-head of the company, enclosing a copy of the cover-page of one project undertaken by the company in the past and details of other projects undertaken in a listed format; by 14<sup>th</sup> April 2022.

4. **Timeline for completion of work:** The above-mentioned work should be completed within 45 days from the effective date of contract. Please note that contract can be cancelled unilaterally by the Consulate in case there is any delay or unsatisfactory work noticed.

5. **Liquidated Damages:** Mission reserves the right to levy penalty @0.5% of contract value per week of delay beyond the scheduled date of completion of project subject to maximum penalty of 10% of the order value.

6. **Bid Security Declaration:** The bidder shall furnish a Bid Security Declaration to the effect that if the bid is withdrawn or modified during period of validity or if after being awarded the contract the bidder fails to sign the contract, the bidder will be suspended for a period of 05 years.

7. **Defect Liability Period:** During the defect liability period Construction should be free from all defects. The firm agrees to undertake minor or major repair works, if any, without any cost to the Consulate, for the next 12 months from the date of hand over.

8. **Payment Milestone:** The 90% payment will be made after completion of work and acceptance by the Consulate and remaining 10% payment will be released after 12 months from the date of completion of work and acceptance by the Consulate.

9. **Advance Payment:** No advance payment will be made.

10. **Last date of submitting bid:** 14<sup>th</sup> April 2022.

The bids may be addressed to the office of Consul (HOC), Consulate General of India in Ho Chi Minh City, 214 Vo Thi Sau, District 3, Ho Chi Minh city, Vietnam. *Bids must be submitted in sealed envelope mentioning the title of the project "Proposal for installation of the bust of Mahatma Gandhi in HCMC" on the cover of the envelope.*


11. **Time and date for opening of bids:** 1100 am on 18<sup>th</sup> April 2022 (If due to any exigency, the due date for opening of the Bids is declared a closed holiday, the Bids will be opened on the next working day at the same time or on any other day/time, as intimated by the Consulate).

12. **Place of opening of the Bids:** The bids will be opened in the office of Consul (HOC), Consulate General of India, 214 Vo Thi Sau, District 3, Ho Chi Minh City. The bidders may depute their representatives, duly authorized in writing, to attend the opening of bids on the due date and time. Rates and important commercial/technical clauses quoted by all bidders will be read out in the presence of the representatives of all the bidders. This event will not be postponed due to non-presence of your representative.

13. Enquiries will be entertained only before 13<sup>th</sup> April 2022. No enquiries will be entertained thereafter.

14. The Consulate General of India will contact the successful bidder by email and phone; unsuccessful bidders will not be contacted or entertained.

15. The Consulate General of India, Ho Chi Minh City reserves the right to accept or reject any bid or cancel this tender without awarding any reason whatsoever at any stage, before the final award and signing of the contract.
